Program Fees, Payment Form and Directions

Thank you for applying to the 2024 Amelia International Conservation Studies program. There is

a limited number of places for all AICS programs and, for your application to be considered, we must

receive your application fee of €50. This fee is non-refundable unless the program for which you apply

is cancelled by AICS (see refund policy below). We must also receive the program deposit of €450

before March 15 for your application to be valid. Please read our COVID Policy and Guidelines.

2024 Total Costs

One program = EUR 3,500

These fees include tuition, accommodations, deposit, and application fee. They exclude airfare, food

and required insurance.

Methods of Payment:

We do not accept checks from foreign banks, nor do we accept checks or money orders in currency other

than euros.

1. Wire transfers in EURO (must include €10 per wire transfer to cover bank fees). This is usually how

participants from outside Europe pay.

Note: The Amelia International Conservation Studies program may be cancelled if the minimum

enrollments are not met. You will be informed of such a cancellation after March 15, 2024.

Please do not make travel arrangements until you have been accepted and received confirmation

that the program will take place. AICS reserves the right to review the applicants and determine who

will be accepted into the programs. Please read the AICS COVID Policy regarding vaccination and other

requirements for participation.

Refund Policy: On March 15th, 2024 we will establish if we have the enrollment required for the

program to go ahead. Should the program be cancelled due to low enrollment, or any other AICS

decision, applicants will be fully refunded. If an applicant withdraws their application before the March

15th deadline, they will be refunded the €450 deposit but not the €50 application fee. Those students

that withdraw their application after March 15 will not receive a refund of either the application fee or
