



AICS 2024 Program Liability Release Form

I hereby undertake to indemnify and absolve from all liability the Amelia International Conservation Studies Program, the Art Restoration and Conservation International Field School (ARCIFS), their officials, agents, and employees, from any and all losses, damages, expenses, or costs that may be incurred or sustained by myself. I acknowledge that these liabilities may encompass harm to my personal belongings, personal injuries, or loss of life arising out of my actions in the course of the Amelia International Conservation Studies Program, taking place from June 10 to July 5, 2024.

The restoration field activities, workshops, and site visits may entail various tasks such as, indicatively, ascending scaffolding and ladders, handling tools and hazardous substances during the restoration process of historical monuments, and engaging in workshops on paper restoration. Moreover, the program may encompass on-site visits to construction areas involved in restoration projects, as well as travels to neighboring cities and sites for research purposes, both under the supervision of faculty or staff members and independently. The Program assumes I am a participant who is a competent and accountable adult, capable of undertaking the independent travel that may be necessary.

I acknowledge that my involvement in this endeavor carries inherent risks, potential hazards, and consequential outcomes that exceed the typical risks encountered within a controlled classroom setting. Such risks include, but are not limited to: unintentional cuts, abrasions, fractures, or even severe consequences such as lasting injuries or loss of life, as a result of working in the vicinity of buildings in deteriorated conditions, engaging in archaeological sites, and visiting construction areas. By partaking in this undertaking, I willingly abide by the safety rules indicated by the Program and assume complete responsibility for safeguarding my own health and well-being. Moreover, I comprehend that by affixing my signature to this document, I am irrevocably relinquishing certain specific legal entitlements.

I hereby consent to procuring medical and accident insurance that shall adequately cover any and all medical expenditures I may accrue while participating in the program, as well as subsequent to the program (in instances directly linked to my involvement with the Amelia International Conservation Studies Program). It is understood that such insurance coverage shall extend to costs not encompassed by the mandatory travel insurance provided by CISI.

I am aware that the mandatory insurance policy exclusively encompasses medical expenses and repatriation costs arising from/ due to accidents or illnesses while in Italy. It does not extend coverage to pre-existing conditions nor to medical expenses incurred subsequent to my return to my home country. Notably, the policy treats COVID-19 as it would any other illness, entailing coverage for testing, medication, doctor visits, and hospitalization. However, testing is only covered if deemed medically necessary, contingent upon illness or displayed symptoms. I commit to thoroughly reviewing the insurance provisions outlined in the CISI policy and diligently ensuring supplementary coverage for any additional policies deemed essential.
